SECTION D

- Mrs Gupta lives with her 80 years old mother-in-law in a rented house in Patna. The rent of the house was Rs 10,000 which was paid regularly during the initial three months but after four months Mrs Gupta could not pay the complete rent for three months and her payments were delayed by 15- 20 days. On observing this as a regular practice of the tenant, the landlord sends her a legal notice for clearing the dues and vacating the house. On knowing this the lady seeks your advice, she wishes to know that how she can be given some more time to pay the dues and she informs that she does not want to vacate the house. During the interview, you observed the lady to be in pain and anxiety.
 - a) How will you perform your duty as a counsellor in making the lady feel relatively comfortable?
 - b) Knowing the fact that she is deeply in pain, how will your collect the information from her, which seems difficult at that state? Write your dialogue with her.
- A panic client comes to the clinic to seek legal help and support. After sharing the details of the case, he asks you straight: "Can I win the case?
