<b>Q 12</b>	Department of shipping and cruise of the State of Indiana, where laws are <i>pari materia</i> to Indian laws, framed a rule that female officers of merchant navy cannot go oversea ship journey after their marriage, where as married male officers can go. Mrs. Rai Cahudhary a senior married lady officer has challenged the constitutional validity of this rule in the Supreme Court of Indiana. In addition to this she has alleged that some male officers junior to her have been promoted before her. She challenged such gender biased discriminatory rules as against the constitution of India as well as against international human rights laws related to the women rights. Consider yourself as a Supreme Court judge of the State of Indiana and give her justice. Discuss in the light of relevant laws and treaties along with decided case laws, if any.	<b>25</b>	<b>CO 3</b>
<b>Q13</b>	Mr. Bekasur Singh was arrested in 2007, in concern with Bhalegaon blast case. However, no charge sheet was filed against him till 2015. Pending filing of the charge sheet his bail was denied many time. In 2015 his wife Bechari Devi has filed a petition in the Supreme Court of India, with special permission on the basis of gross injustice being done because of the slow trial. She alleged that the police has no evidence against his husband and this case is a fake case created because of political reasons. Her husband is continuously being tortured by the police in custody to confess the crime which he as not committed at all. Police investigation could not gather any evidence even in eight long years. She alleged that a painfully slow speed of criminal trial is a violation of international human rights law and also right to life as mentioned in the constitution of India.
