	<p>XYZ Enterprises is planning to raise an additional capital of Rs 1200 crores by way of 250 crore debt. 200 crore Preference equity, 600 crore Common Equity and 150 crore Retained Earning.</p> <p>The firm can issue Rs100, 5 year 13% debentures at a discount of 20% per debenture to be redeemed at 20% premium. The issue expenses would be 8 % . The organization plans to issue a Rs 10, 15% 6 year preference share at a premium of 10% .The issue expenses for the preference share would be 6% on face value.</p> <p>For equity the company intends to issue a Rs 10 common equity share at a premium of 25% and flotation cost is 10% of issue proceeds.
